The variable supplemental distributions are payable to shareholders of record as of the open of business on June 28, 2024, and will be paid on or about July 31, 2024.

These distributions will be paid in cash or reinvested in shares of the Fund for shareholders participating in the Fund’s distribution reinvestment plan.

As of May 31, 2024, the Fund’s aggregate NAV was \$557.0 million, the fair value of its investment portfolio was \$852.4 million and it had principal debt outstanding of \$300.0 million, resulting in a debt-to-equity ratio of approximately 0.54 times.

Status of Offering

The Fund is currently publicly offering on a continuous basis up to \$1.0 billion in Shares (the “Offering”). The following table lists the Shares and total consideration for the Offering as of the date of this filing (through the June 1, 2024 subscription date). The Fund intends to continue selling Shares in the Offering on a monthly basis.
