

2024 Section 163(j) Interest Dividend Information

A portion of the dividends from Fidelity Private Credit Fund may be eligible to be treated by corporate (and certain other) shareholders as Section 163(j) interest dividends and thus as business interest income when determining the limitation on their business interest expense deduction.

To determine the amount of each dividend you received in calendar year 2024 that may be eligible to be treated as business interest income multiply the amount of ordinary dividend income that you received from the fund by the corresponding Section 163(j) interest dividend percentage from the table that follows. The amount of each ordinary dividend you received is reported in the Detail Information portion of your 2024 Informational Tax Reporting Statement, within the Details of Dividend and Distributions Transactions section>Total Ordinary Dividends and Distributions Detail>Total Ordinary Dividends.

The following example shows how a Fidelity® Private Credit Fund Class I investor would calculate the amount of each ordinary dividend that may be eligible to be treated as business interestincome.

In this example, \$12,000 may be eligible to be treated as business interest income.

Please note that business interest income treatment is generally inapplicable to dividends on fund shares that are not held for at least 181 days during the 361-day period that began 180 days before the applicable ex- dividend date.
